Inpatients

Inpatient charges are inclusive of a programme of nursing care, physiotherapy, occupational therapy and hydrotherapy, and routine pharmacy, medical supplies, and pathology, but exclude consultant professional fees.

Disbursements

All non routine professional fees, examinations, investigations, equipment, pharmacy and medical supplies are charged as disbursements in addition as required. They are dependent on the patient's condition and the Consultant's recommendations.

Visitors Expenses

Visitors Meals, from	£8.00 per meal
Visitors Accommodation, En-suite room from:	£35.00 per night
Flats with self catering facilities	£45.00 to £65.00 per night
Personal Laundry	charged per item
Faxes	£2.00 per page

It is strongly recommended that relatives / visitors accompanying patients from abroad arrange travel / health insurance for the duration of their stay.

Deposits

The Centre requires a deposit before the admission of a patient. The amount for the deposit is negotiated prior to admission depending on patient requirements and length of stay.

Private Medical Insurance

Insurers can only be invoiced directly by the hospital if they have pre-authorized the patient's treatment in writing or by issuing a letter of guarantee.

If treatment is not authorised in advance by the insurer, patients must pay at the end of each treatment session.

A receipted invoice will be issued for the patient to claim the cost directly from the insurer.

Self Funding

A package rate can be agreed for patients funding their own care.
